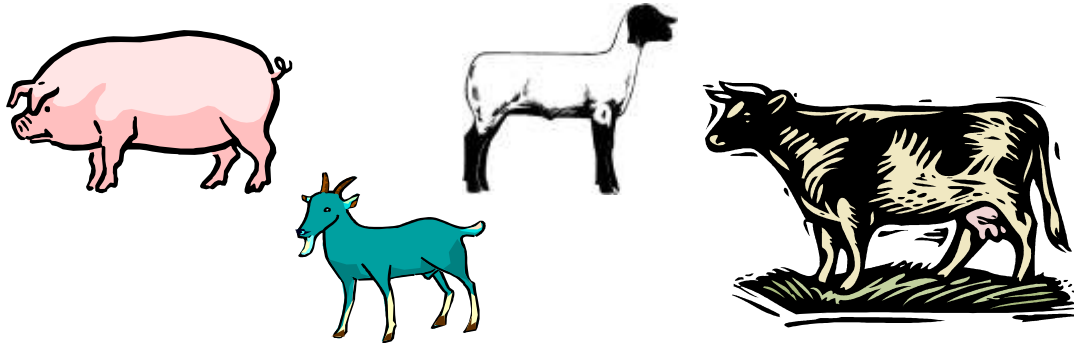

PROJECT RECORD BOOK COMPETITION

IMPORTANT: Show premiums will be withheld if no Project Record Book is turned in by the Exhibitor.

Exhibitors are required to submit at least one Project Record Book, but are encouraged to submit books for each species entered in the Rockbridge County Fair.

Project Record Books will be judged in these categories:

- Junior (ages 9-11 as of September 30, 2011)
- Intermediate (ages 12-13 as of September 30, 2011)
- Senior (ages 14-19 as of September 30, 2011)

Project Record Books will be separated by species and judged against the criteria listed below:

- Exhibitors are reminded that this is a Project Record Book and not a scrap book.
- Exhibitors are encouraged to limit the number of extra pages added to the Project Record Book to two (2).
- Pictures of the Exhibitor and the project animal are acceptable.

Completed Project Record Books are to be submitted to the Rockbridge County Extension Office no later than 5:00 p.m. on Friday, August 5, 2011. Late books will not be eligible for awards. If the Project Record Book is found to be incomplete, no premium will be awarded!

GENERAL PROJECT RECORD BOOK GUIDELINES

It is suggested that a copy of the Project Record Book be made for use as a "Work Copy". Records may then be transferred into this Project Record book for a "Final Copy".

- Your Project Record Book should begin when you purchase your animal(s).
- Only one project may be included in each Project Record Book. If you are having more than one project (different species of animals), in the Rockbridge County Fair, you must have a separate Project Record Book for each project.
- Project Record Book may be placed in a folder or plastic protector sheets. NO 3-ring binders!!
- Always double check your work; especially math calculations.
- Have someone check your project story for spelling and grammar before you write it in the final Project Record Book.
- Your final Project Record Book should be handwritten in pencil by the Exhibitor. NO computerized books will be accepted!
- **REMINDER: Completed Project Record Books are to be submitted to the Rockbridge County Extension Office no later than 5:00 p.m. on Friday, August 5, 2011. Late books will not be eligible for awards. If the Project Record Book is found to be incomplete, no premium will be awarded!**
